I UNDERSTAND THAT ALL BOOTH ASSIGNMENTS ARE FINAL

I understand that there are limited spaces available and they are first paid, first reserved. Submitting my application does not guarantee me a space. Only after I have been approved and have paid the fee is my space reserved. Booth fees must be paid within 48 hours of approval.

I understand that my fee includes a space that is 10ftx10ft and includes one 6'x3' table and two chairs. Additional tables and chairs MAY be available but are not guaranteed. I understand that I must provide my own table coverings. Pop up Canopies are allowed and encouraged but not provided.

I agree to keep my assigned space in good condition, clean and free of debris and to leave the space clean after I 'tear-down' my space. Failure to do so will result in the forfeiture of my \$50.00 cleaning deposit. I will check out and pick up my cleaning deposit before leaving, or I forfeit my cleaning deposit.  
Cleaning deposits will NOT be mailed to exhibitors after the event.

I understand that there is adequate lighting and that an additional fee of \$25 per electric plug for electricity will be charged, that there are a limited number of plugs available, and the plugs will be given on a first ordered/first paid basis.

I understand that there is no smoking of any kind inside the building, including vaporizers.

I agree to sell or exhibit only items that are intended for enjoyment by the general public. The sale of illegal or legal items that are associated with drugs, pornography (or are objectionable), fireworks, stink bombs, bomb bags, silly string, air soft guns, water pistols or rifles will not be permitted at The Insight Fest. THE SALE OF RESTRICTED ITEMS WILL RESULT IN The Insight Fest ASKING ME TO LEAVE THE EVENT AND THE FORFEITURE OF ALL FEES PAID, INCLUDING MY CLEANING DEPOSIT.

I will not dismantle my booth or remove my merchandise before 9pm on Saturday September 30, 2017. I understand that dismantling my booth or removing my merchandise early will result in the forfeiture of my cleaning deposit.

I will begin dismantling of my booth at 9pm and I will be completely finished no later than 10pm on Saturday September 30, 2017 **I understand that if I have not completed the dismantle and cleanup of my booth area by 10pm I forfeit my cleaning deposit.**

I understand that as the Applicant, I am responsible for my own liability insurance. The Insight Fest does not provide coverage, of any kind, to the Applicant or their representatives.

**Cancellation/Refund Policy: Once you have made a commitment to participate in The Insight Fest by submitting your payment there will be no refunds for any reason.**

**Liability Release:** I hereby agree that I will not hold The Insight Fest, My Guide to Insight, or any of their producers, sponsors, employees, volunteers, agents, or others acting on their behalf liable for any injury or illness, or for the loss or destruction of any personal property that may occur during, or as a result of my participation in the above mentioned event. I hereby voluntarily release, forever discharge and agree to indemnify and hold harmless The Insight Fest for any and all causes of action, which are in any way connected with my participation in the event, including such claims which allege negligent acts or omissions of The Insight Fest.
